QUESTIONS AND ANSWERS:

Question 1. We are referring to the replacement of two forty-foot wooden ramps on the east side of building C. Understanding the scope of work is to repair, refurbish, and repaint the metal handrails while also making them ADA compliant, the spacing of the rails do not appear to be in compliance and some sections are showing significant weathering. The metal handrails on the wood supports need to be extended outward to be compliant with the ADA. Should the contractor exclude the wood sections, on removing and replacing the wood sections, or replace them with metal handrails to comply with ADA standards?

Answer 1. Yes, the handrails should comply with ADA standards. Remove wood sections and replace with metal to meet compliance
