Section 1.0 – Site Visits:

Site visits are being offered for this bid. To set up a site visit, please get in touch with Tim Hoskins between the hours of 8:00 a.m. to 3:00 p.m. Monday-Friday @ 504-364-2675.

Section 2.0 – Scope:

We extend this bid to cover all labor, materials, delivery, equipment, and all other incidentals necessary to clean, coat, layout, paint, and stripe the seventh-floor concrete of the Parking Garage located at 300 Derbigny Street, Gretna, LA 70053.

Section 3.0 – License:

A Louisiana State Contractor's License will be required in accordance with LSA R.S. 37-2150 et. seq., and such license number will be shown on the outside of the electronic bid envelope. Failure to comply will cause the bid to be rejected. When submitting the bid electronically, the license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected." A copy of the license is not required by law; however, they are required to specify their license number on their bid envelope.

Section 4.0 – Bonds:

- **Performance Bond:** A Performance Bond in the amount of 100% of the total contract amount will be required. The performance bond shall be produced upon contract execution.
- **Surety Bond:** An Electronic bid bond will be required with bid submission in the amount of 5% of the total bid. The vendor shall indicate the electronic bid bond number in the location specified on the electronic bid envelope. No scanned paper copies of any bid bond will be accepted as part of the electronic bid submission.

Section 5.0 – Quantities/Inspection:

Bidders must inspect the site and perform measurements to determine the labor, materials, and equipment required to complete this project.

Section 6.0 Submittals:

If the bidder intends to provide materials equal to or better than owner-specified materials, the following shall be provided with the bid submission. Provide the requested information with your bid to ensure the bid is deemed responsive.

- Manufacturer's catalog data
- Detail sheets

Section 7.0 – Bid Specifications:

- Successful bidder and an owner's representative shall inspect, document, and take photos of all existing building and top deck conditions.
- All materials shall be as specified bidder supplied new.
- All materials shall be applied as per all manufacturer recommendations and guidelines. See attachment "A" for the top deck location and areas of the top deck to be coated and re-stripped.
- Any damage caused by this work will be the responsibility of the successful bidder to correct and return to the original conditions.

Section 7.1 – Deck Preparation:

- Remove debris from edges, corners, and under car stops.
- Utilize an industrial sweeper to sweep the entire top deck and ramp to the sixth floor.
- Dispose of all debris.

Section 7.2 – Traffic Membrane Preparation:

- Remove all car stops.
- Presoak the entire deck with Proso 2010 surface cleaner and industrial bleach to assist in removing mold and mildew from the deck.

Section 7.3 – Deck Washing:

- Presoak oil-stained concrete with Proso 2010 surface cleaner degreaser.
- Utilize at minimum a 3000 PSI pressure washer coupled with a 30" wide flat surface cleaner to wash the entire top deck and parapet walls uniformly.
- Rinse the top floor once the flat surface cleaner has covered all areas.

Section 7.4 – Deck Shot Blasting:

- Utilize an industrial shot blaster to shot blast the entire top deck and ramp to the sixth level of the garage.
- Remove all shot blast debris from the sixth and seventh floors.

Section 7.5 – Caulking:

- Remove all expansion joint sealant and backer rod.
- Supply and install new BASF close cell backer rod.
- Supply and install new BASF SI -1 self-leveling sealant to all expansion joints.

Section 7.6 – Large Joint Replacement:

- Remove the large joint system at both ends on the seventh floor.
- Supply and install a new **Watson Bowman Jeene®** joint compression.

Section 7.7 – Traffic Membrane Installation:

- Supply and install a new **MasterSeal®** one-component moisture-curing polyurethane base coat.
- Supply and install a new **MasterSeal®940/941**
- Supply and install a new **MasterSeal®TC225** top coat to create a non-skid surface.

Section 7.8 Striping:

- Design shall match the existing layout.
- Paint shall be applied as per all manufacturer recommendations and guidelines.
- All areas shall be painted using Sherwin Williams® Hotline fast-dry waterborne acrylic traffic paint.
- Parking space striping, curbs, and ramp colors shall be painted with brand colors listed below:

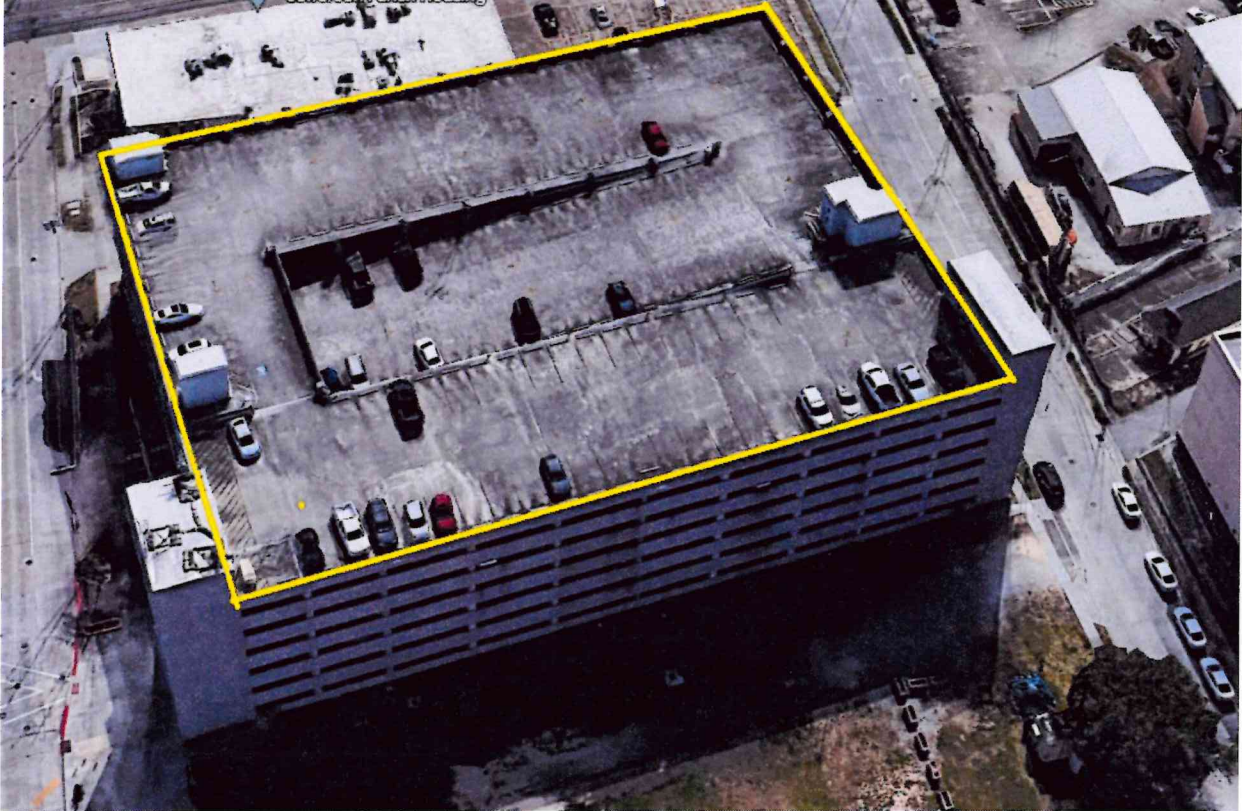

Any changes to the insurance requirements will be reflected in the bid specifications and addenda.
