PRE-BID MEETING MEMO:

A non-mandatory Pre-Bid conference was held on Wednesday, December 20, 2023 at 10:00 AM at the project site. The meeting began with Mrs. Tran reviewing the Pre-Bid Conference Agenda and gave a brief description of the project scope. The following were items discussed.

- Bidders are encouraged to review the front end documents in the Project Manual as all requirements shall be enforced.
- Part 1A documents must be completed and submitted to Purchasing Division Prior to Bid Opening.
- The last day for Bidders question to the Architect is **ten (10) working** days prior to bid opening.
- Bidders must submit product substitutions or prior approval request to the Architect no later than seven (7) working days prior to the opening of bids.
- The estimated budget: Will be disclosed at the Bid Opening.
- The contract time is 120 Calendar Days, \$430.00/Day Liquidated Damages.
- There are three allowances; Misc. Steel, HVAC, AND Lighting.
- The City Parish does not recognize "Certificate of Substantial Completion". Bidders to refer to The City-Parish Final Acceptance Process under Specification Section 01 00 00 City Parish Summary of Work.
- The contractor or vendor is responsible for securing the required permits, however the following fees will be paid directly by the Owner:
 - o Plan Review Fees
 - o Permit Fees
 - o Sewer Impact Fees
 - o Traffic Impact Fees
- The City Parish will engage and pay for the testing laboratory if required.
- There is one ADDITIVE alternate to provide interior build out of the new Sleeping Quarter.
- The building will remain open throughout construction. Bidders shall be allow to work after hours and on weekend with prior approval from owner. Bidders shall give the owner 24 hours notice for after hour work.

A tour of the interior and exterior of the Brownsfield Fire Station #72 building then took place.
