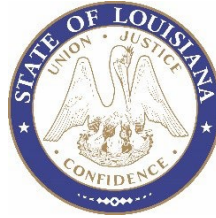

ADDENDUM NO. 01

Your reference is directed to RFx Number 3000022421 for the Invitation to Bid for the State of Louisiana – HPV & PAP Lab Services for LDH, which is currently scheduled to open at 10:00AM CDT on 02/15/24.

The following changes are to be made to the referenced solicitation:

Questions from the Vendor and State's Responses:

Vendor Question 1. What assurances can you provide that all staff from OPH, Intergy EHS and Greenway Health will be made available and will prioritize the project to develop the bi-directional interface with OPH's current version of the EHR software within the 90 day time required?

State's Response: With the additional information being provided (see answer to 2), it is expected the Vendor will follow the necessary steps to be interfaced with Greenway/Intergy EHS. The State can assure that any additional information required to become interfaced will be provided after an award is made, if such information is needed.

Vendor Question 2. Are there any specifications you can share on the bi-directional interface requirements?

State's Response: The State is unable to provide specifications or requirements on becoming bi-directionally interfaced on Greenway's/Intergy's behalf. Vendor Question 3. Can the current version of the EHR software support lab orders and lab results using HL7 v2.3.1?
