Introduction:

Lallie Kemp Regional Medical Center is pleased to announce a bid that will provide linen services to the Hospital. The Hospital is a state public hospital located at 52579 Highway 51 South, Independence, LA 70443. Please refer to the below specifications for the bid requirements.

Effective Date and Term:

The awarded contract will have an effective date of July 1, 2024 through June 30, 2025. Lallie Kemp Regional Medical Center shall have at its discretion the option of renewing for two (2) additional one year terms at the same terms and conditions for a period not to exceed thirty-six (36) month.

<u>Vendor Experience:</u>
The awarded vendor must have a minimum of 3 years of providing linen services within a healthcare setting. The vendor shall be accredited by the Healthcare Laundry Accreditation Council (HLAC).

Leased Laundry:

The awarded vendor will provide all linen for Lallie Kemp Regional Medical Center, including but not limited to sheets. pillowcases, blankets, scrubs, cubicle curtains, towels, washcloths, etc.

Clean Linen:

The provider must ensure that the user receives hygienically clean linen. Acceptable linen standards should be established jointly by the provider including:

- 1. Processing procedure and technique. Vendor must provide documentation and identify chemicals used in the cleaning/rinsing process to show compliance with state guidelines.
- 2. Physical appearance of linen must be acceptable.
- 3. Condition of linen must be acceptable for Infection Control Officer and Housekeeping Manager.
- 4. Items returned for rewash, will not have a charge fee.
- 5. All sheets and pillowcases shall be finished by flatwork ironer. All other linen shall be fluff-dryed and folded, Scrub pants, scrub shirts and warm-up jackets shall be tunnel finished and folded. Lab coats shall be pressed and delivered on hangers.

Replacement Linen:

Replacement linen must be included for all linen damaged, stained, lost, or deemed not acceptable. Par levels must be replenished to ensure adequate service to our facility. If a delivery is made that contains damaged, lost, or stained linens that results in our inventory being below par levels, then replacement linen must be delivered as soon as possible or no later than the next day.

Delivery Process:

- 1. Clean linen shall be transported in clean containers used exclusively for this purpose.
- 2. Placing clean linen in a cart, lined with a clean liner is acceptable.
- 3. This cart should then be covered with a clean cover, or the liner must be secured to preserve the integrity of the clean linen.
- 4. The container used to transport soiled linen is to be properly cleaned and disinfected before it is used to transport clean linen.
- 5. Each cart of clean linen shall have a packing slip listing its contents, itemized by description and total weight listed in pounds.

Personal Items Found In Laundry:

Personal items (billfolds, jewelry, glasses, dental devices, etc.) and medical items (splints, etc.) found in soiled linen carts shall be safely and securely packaged and returned to Lallie Kemp Regional Medical Center promptly with a documented report.

Reports:

Vendor to furnish semi-annual reports on cultures of linen samples to the Hospital's Housekeeping Manager and Facility Director for review by the Hospital's Infection Control Officer. These reports shall be available as requested by Hospital staff.

Properly Cleaned Procedures:

Cleaning procedures and maintenance of containers, liners, and covers shall be approved by the Hospital's Facility Plant Director and Infection Control Officer. Written procedures of cleaning and maintenance of containers used for transport must be approved by the Hospital's Infection Control Officer and Facility Plant Director. Inside areas of vehicles and trailers used for transport must be kept clean at all times.

Plant Facilities:

The laundry facility should be designed, equipped, and ventilated to minimize the dissemination of microbial contaminants. Semi-annual reports on infection control for our linen being delivered will be required. These reports shall be available as requested by Hospital staff. Lallie Kemp Regional Medical Center shall have the right to inspect the vendor's laundry facility where the linen is being processed. These inspections may be announced or unannounced and occur annually or more frequently as circumstances are deemed necessary.

Disaster Plan:

The vendor shall provide a written contingency plan to Lallie Kemp Regional Medical Center indicating alternative provisions that may be followed if the vendor is unable to meet the production requirements of the user. This plan shall be included in the contractual arrangements, which may include an off-site vendor or source. In this event, the linen must be kept within the standards of the contract for cleaning and delivery of the linen to our facility.

Cubicle Curtains:

Curtain cleaning shall follow the same guidelines as other linens. Curtains shall be pressed and delivered on hangers.

Service Times:

Delivery of clean linen and pickup of soiled linen shall be made on Monday, Wednesday, and Friday of each week including holidays between the hours of 6:00 AM and 9:00 PM.
